DESCRIPTION: This Housekeeper position is assigned to the Missouri State Highway Patrol's Troop C Headquarters. The official domicile for this position is Weldon Spring, Missouri. This position is classified as non-exempt under the Fair Labor Standards Act.

POSITION SUMMARY: An employee in this class performs manual work involving a variety of housekeeping tasks performed under close supervision. Work is assigned and performed in accordance with established routines. Instructions are specific in nature and work is subject to close inspection during progress and upon completion.

QUALIFICATIONS: **Housekeeper I:** Graduation of the eighth grade. **Housekeeper II:** Graduation of the eighth grade AND possess at least one-year experience as a Housekeeper I or comparable experience. **Housekeeper III:** Graduation of the eighth grade and possess at least one-year experience as a Housekeeper II or comparable experience.

SALARY RANGE: (Semi-monthly) The minimum starting salary is \$810.00; however salary may be commensurate with experience.

APPLICATION PROCEDURE: Individuals interested in this Housekeeper position must submit the Patrol's on-line application prior to the application deadline. Resumes will not be accepted in lieu of the application. Please visit our website at www.mshp.dps.mo.gov to complete an on-line [Application for Civilian Employment \(ACE\)](#). Individuals who have previously completed an application must access their profile in the ACE system to re-apply.

Current employees who meet the minimum qualifications set forth in the Housekeeper job description may apply through the Human Resources Division by submitting an intradepartmental letter of application and resume through channels prior to the application deadline.

Interview boards are tentatively scheduled for the week of March 4, 2013. The tentative start date for this position is within 30 days of the interview.

Some Patrol duties relate to criminal activity. Therefore, employees may be exposed to written material, photographs, and/or verbal language of a sexual nature. The requirements of this position are not intended to create a hostile work environment; however, it is work of an extremely sensitive nature.
